Procedure

1. Heat phase A with mixing until homogenous; cool to ambient temperature
2. Combine phases A and B
3. Add combined phases A and B to a continuously stirred solution of phase C
4. Mix the combination for 5 min or until homogenous
5. Store in appropriate container
